- 1. The procurement will be done under Punjab Procurement Rules-2014 by using single stage one-envelope bidding procedure and will be evaluated on **Least Cost Basis**.
- 2. As per PPR-2014 Bid Security @ 2% of estimated price of Rs. 4,080,000/- in shape of CDR, Bank Draft, or Pay Order in favor of "Lahore Knowledge Park Company" should be submitted, without which the offer shall be rejected being non-responsive.
- 3. Tenders received after the due date & time will not be brought under consideration.
- **4.** Copies of Income Tax and Sales Tax number should be furnished by the firm along with the tender.
- **5.** Initially, the contract will be for the period of one year but can be renewed for further two years on yearly basis within the estimated amount mentioned and after approval by the Competent Authority.
- **6.** The Competent Authority may reject all the bids or proposal at any time prior to the acceptance of bid or proposal as per Rule 35 of PPR-2014
- 7. The Financial Bid shall be considered as inclusive of all taxes.
