

2. Introduction

The Lahore Knowledge Park Company (LKPC) was incorporated in October, 2014 as a Public Sector Company under section 42 of the Companies Act, 2017 registered with the Securities & Exchange Commission of Pakistan. The Company is governed by its Board of Directors comprising of 5-ex officio and 6-members from Private Sector. The parent department of the Company is Higher Education Department (HED).

The Government of Punjab has allocated a piece of land measuring around 852 acres situated at Rakh Dera Chahl, Bedian Road, Lahore to the Higher Education Department for the development of Lahore Knowledge Park. The LKPC is mandated to develop, maintain and manage Knowledge Park(s) in the province of Punjab and assigned the responsibility to develop Lahore Knowledge Park as per the vision of Govt. of the Punjab.

The Vision statement and Mission statement are as follows: -

Vision Statement

Excellence in Knowledge & Enterprise.

Mission Statement

- Deliver an enabling ecosystem for innovation, enterprise and thought leadership.
- Attract investment, partnership and joint venture in contemporary technologies and cutting-edge manufacturing.
- Create value chain transforming knowledge to economy.
- Proactive interface for creativity to commercialization.
- Provision of customized infrastructure and services for functioning of reputed national and international universities, colleges, institutes and hi-tech industry.
- Provision of state-of-the-art environment for attracting highly skilled professionals to LKP.

3. Scope of Services

- LKPC invites proposals for setting up electricity power generation plant, testing, commissioning
 as managed services and Operation & Maintenance (O&M) in the vicinity of Lahore Knowledge
 Park.
- The power supply solution needs to be rolled out for approximately 800 acres of land within Lahore Knowledge Park.
- The power/electricity requirements will be as per following forecast:

Year 1-2 (Phase-I)	200 Megawatts
Year 3-6 (Phase-II)	300 Megawatts
Year 6 onward (Phase-III)	400 Megawatts

- There must be provision of increasing the requirements to any desired higher value on demand for a limited time.
- Service provider will provide 100% uptime in O&M agreement for electricity.
- The Firm will invest all the cost involved in setting up power plant and will be responsible for its operations.
- Arrangement of fuel will be the sole responsibility of the Power Producer.
- Operation and maintenance will be sole responsibility of the Power Producer on its own cost.
- The payments shall only be made on the "Take and Pay Basis'. The 'Take and Pay Basis' means LKPC willpay the Power Producer for dispatched and delivered net Electrical Output.
- Maintenance shutdown will be carried out with coordination/prior approval of LKPC.

4. Eligibility Criteria

- 4.1 The Firm is required to submit proposal.
- 4.2 The Firm is required to submit the following **mandatory** documents for further consideration for eligibility. The Firm:
 - Shall have power generation License or may arrange within stipulated time as agreed.
 - Shall have permission from NTDCL or any other government organization or may arrange within stipulated time as agreed.
 - Shall have experience of 5 years in the field of Power Generation and distribution.
 - Shall have registration with FBR for Income Tax and Sales Tax and relevant authorities.
 - Shall have Financial soundness showing by the last 3 years Audited Accounts duly audited by any Chartered Accountant Firm.
 - Shall have sufficient Managerial and Technical human resources to accomplish the project in effective manner.
 - The Company is not blacklisted by any Government/Semi Govt. or Autonomous body or in litigation with any Government organization (Provide undertaking on Stamp Paper).
 - Plant must be able to supply 24/7/365 electricity.
- 4.3 A summary table and supporting documents substantiating previous experience of similar transactions (preference shall be given in case of transactions dealt with WAPDA, NTDCL, GENCOs, DISCOs and private sector etc.)

5. Instructions

All partners of the Consortium/JV shall be liable jointly and severally for the execution of the contract in accordance with the contract terms and conditions and a statement to this effect shall be included in the Undertaking to be submitted. The Undertaking should clearly authorize the Prime Applicant to act on their behalf for the entire Process and execution of the contract.
